The partnership between UNFPA and Germany focuses on addressing the needs of young people, delivering life-saving humanitarian assistance and procuring contraceptives through UNFPA Supplies Partnership, our flagship programme on family planning. Furthermore, UNFPA promotes public-private partnerships for the advancement of global health, with private sector actors like Bayer. This partnership focuses on improving women's health, expanding access to modern contraception, and strengthening reproductive health services in low- and middle-income countries.

A **champion** for maternal death and ending female genital mutilation

Every woman and newborn is entitled to quality health care. Through its support for UNFPA, Germany helps countries with high maternal mortality strengthen health systems and train midwives. With partners like Germany, UNFPA is working towards a world where no mother or newborn dies during pregnancy, childbirth or after delivery due to preventable causes. Germany has been an indispensable partner in programmes aimed at ending child marriage and harmful practices, such as female genital mutilation, so girls can continue their education and realize their full potential.

A **partner** for innovation

Through investment in innovation, Germany enables UNFPA to leverage its global footprint and expertise through collaborative and inclusive partnerships with national and international stakeholders, academia, private sector and communities, to close women's health gaps with solutions such as advanced products or process innovations.

Germany is also hosting the WomenX Collective Global Hub, an innovative UNFPA programme aiming to transform the health of every woman and girl.
